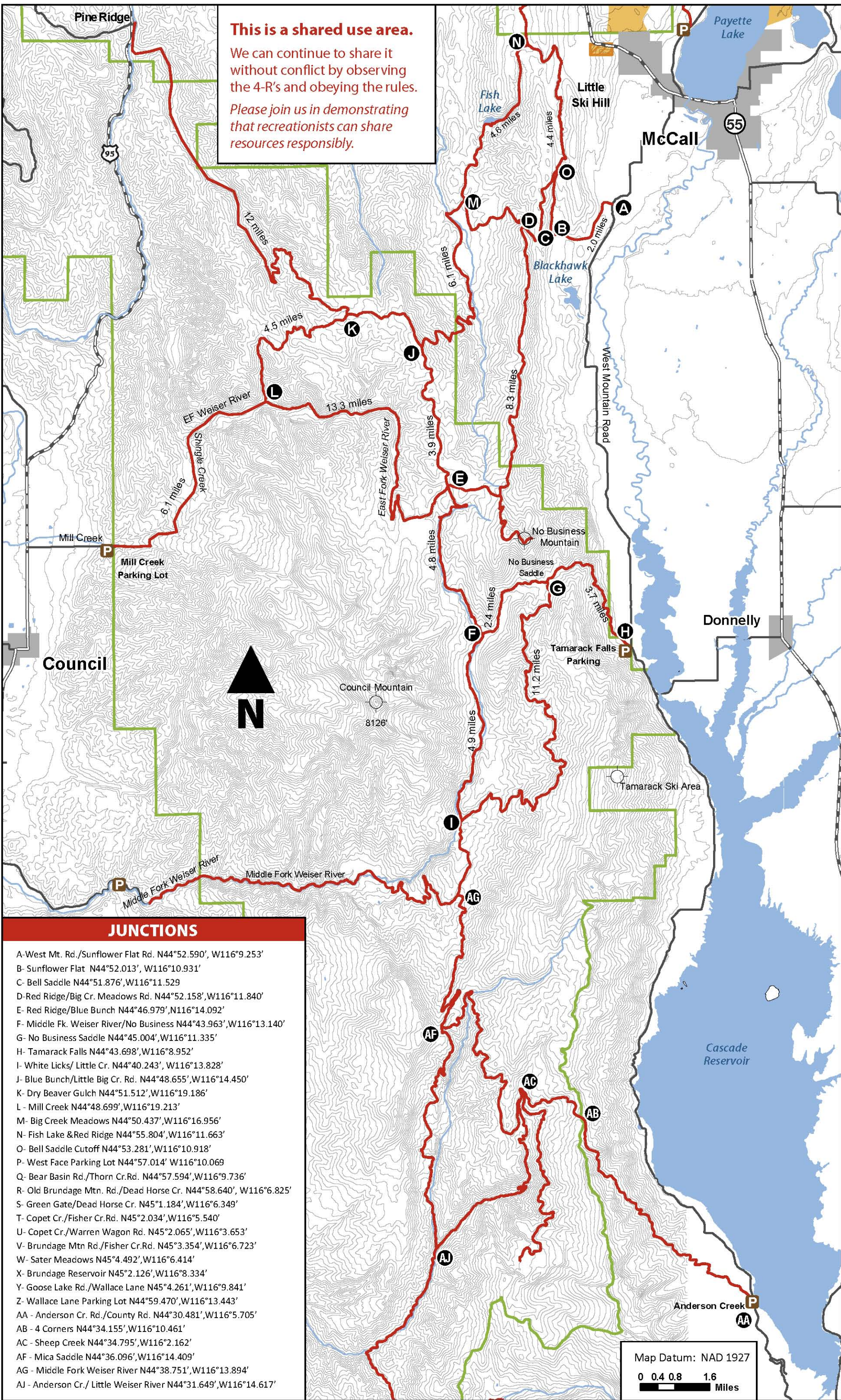


This is a shared use area.
